Investment Advice and Order Transmission

In accordance with applicable regulations and in respect of the provision of non-independent investment advisory services and the receipt and transmission of orders on behalf of third parties, the Bank reserves the right to receive management fee retrocessions received by the management company of a UCI marketed by the Bank. This retrocession will be calculated on the basis of the net assets of the UCI concerned in accordance with the investment agreements concluded between the Bank and the management companies of the UCIs distributed by the latter. Details of the rate and amount applicable to the transaction carried out by the investor will be presented to the investor before subscription, then annually, after the provision of the service.

Transactions carried out on UCIs marketed by the Bank may also result in the Bank collecting load fees, the maximum amount of which may vary depending on the UCI, will be indicated in the regulatory documents of the relevant UCI (in particular the Key Investor Information Document (KIID) or Key Information Document (KID). The investor will be informed by the Bank, prior to subscription, of the amount of these entry fees.

1.2.1 Stock market orders - Securities account

These fees are quoted exclusive of Securities Acquisition Tax, at the rate applicable on the date of publication of the brochure of 0.3% of the transaction amount (rate subject to change).
